Consistory

The following are Consistory positions available for the upcoming year. The Consistory is the governing board of the church. Consistory members serve two year terms, which are renewable once.

Each of our five major standing committees has two persons on Consistory, one who is the Vice Chair of that committee, and the other is the Secondary Liaison of that committee, in order to have two persons to help facilitate good communication between the Consistory and major committees.

On Consistory are 5 Elders, 5 Deacons, 2 Trustees, 2 Youth Representatives, and the Pastor.
